The main goal of this Concept, adopted on May 27, 2019, is to form and develop environmental knowledge, awareness and culture among the growing younger generation, effectively organize the process of environmental education, as well as further improve science in the field of ecology by involving the world's advanced innovative technologies. To achieve this goal and put it into practice, the following main tasks are required:

- To establish the basic principles of developing environmental education in the system of continuous education in accordance with the Laws of the Republic of Uzbekistan "On Education" and "On Nature Protection", to consistently and gradually implement them in the educational process and, on this basis, to bring the effectiveness of environmental education to a new level;
- To organize environmental education, the promotion of environmental knowledge, publishing activities, competitions, social advertising, etc.;
- to improve educational programs based on the elimination of existing environmental problems and the requirements of the time;
- to draw the attention of learners to universal environmental problems, thereby increasing their responsibility for the preservation and rational use of non-renewable resources of mother nature;
- to develop and introduce effective forms and methods of environmental education;
